GUAM TAX AND REGULATORY STRUCTURE AND OVERVIEW

The U.S. Congress created the Territorial Government of Guam as a separate taxing jurisdiction by enactment of the Organic Act of Guam in 1950. Section 31 of the Act provides that the income tax laws in force in the United States shall be the income tax laws of Guam. In effect, the U.S. Internal Revenue Code constitutes the Guam Territorial Income Tax Law as administered by DRT. In addition to administering the GTIT, the DRT also administers other local taxes on Guam, including the Business Privilege Tax, Real Property Tax, Excise and Tobacco Tax, Liquid Fuel Tax, Use Tax, Hotel Occupancy Taxes and Automotive Surcharges. DRT issues Real ID and non-Real ID compliant Guam IDs and Driver's Licenses and Vehicle Registrations. The Agency houses the Guam Passport Office and is responsible for the regulation of the Insurance, Securities, Banking and Real Estate industries as well as commercial motor carrier safety through Motor Carrier Safety Assistance and the Official Vehicle Inspection Station programs. The Department has oversight over and provides support for the Alcoholic Beverage Control Board, Banking & Insurance Board, Board of Equalization, Cannabis Control Board, and the Real Estate Commission.

11 GCA Subsection 1103:

Purpose of the Department

"[The Department] shall be charged with the enforcement of the tax laws of Guam and the collection of revenue. It shall also be the government agency responsible for licensing and registration as allied and connected enforcement functions."



DEPARTMENT ACCOMPLISHMENTS

- Released DRT's COVID-19 Services Volume Series via online and media channels, in response to DPHSS Health Advisories
- Administered Economic Impact Payment program for Guam residents authorized by the CARES Act (EIP1)
- Implemented the Governor's Temporary Economic Assistance and Mitigation Guam Plan
- For the first time in approximately six years, arranged for the US Internal Revenue Service to provide in-person training for the Collection team in Guam
- Worked to expand services by mail and drop box to address issue of public health emergency
- Ensured continued processing of income tax returns

DEPARTMENT CHALLENGES

- Increased responsibilities due to new mandates and increased demand for services
- Challenges with meeting mandates due to lack of financial and other resources
- Lack of opportunities for staff development and retention
- Challenges with automating of services so that customers are able to access from work, home, or via handheld devices
- Need for a conducive work-place and working environment
- Need to do timely updates of department-wide Standard
 Operating Procedures as new mandates take effect
- Implementing and enforcing department related unfunded mandates.

CURRENT AND FUTURE OUTLOOK

The COVID-19 pandemic caused two shutdowns for the island in FY2020. In spite of this, the Department continued its services with its mandate to collect the revenues which finance our government's operations. We worked to ensure that we continued to provide services for our people, even if on a limited basis, given the public health emergency. In anticipation of the lifting of public health restrictions, we created a safe, socially-distanced environment in order to conduct face-to-face business. When the federal government provided monies for economic relief, we streamlined the processes and were able to disburse the funds to qualified individuals in a timely manner.

In the face of recurring challenges and added strain on our workforce and its resources, our staff continues to work to meet our agency's voluminous mandates. Income tax refunds have been processed on a consistent basis. Enforcement across all tax and regulatory fronts has intensified during the year, and we continue to wage an educational campaign to increase voluntary compliance. As we move into the future, our plans include a greater push toward the automation of services and use of technology.
