**D) Other items for Discussion(s):**

**1.) Alcoholic Server/Training Program**

*Members of ABC Board were issued/provided copies on Bill No.9-33(Cor)*

Mary Rhodes, President of GHRA is also in attendance. She is following up on the status of her proposal. She wanted to let the board know that the current law is unclear about trainer's license and fees. If trainees are paying \$60 per class, what do trainers pay to be certified as trainers? Some programs charge both books and fees. Ms. Rhodes had also asked the master manual to be returned after review.

**2.) Change of Tradename:**

The board unanimously approved change of tradename of the following - H Foods, Inc. dba Just Lose It. A Class 4, On Sale Wine License #13024. Changing trade name to The Urban Fork.

**3.) Bottom's Lounge**

Chairman Leon Guerrero shared his experience when he visited Bottom's Lounge. At the time of his visit, he'd found that the club owner is in violation of not closing the bar on time. In attendance at meeting today, Ms. Francis Pickelsimer and Manager Wendy James were present. Bottom's Lounge license is currently up for renewal, and Chairman Leon Guerrero invited Ms. Pickelsimer and Ms. James to speak on how the club and herself to speak of the incident when cops were called for assistance. Ms. James said that they've been implementing last call at 1:45am since he incident, and that the owner ensures she would not be drinking during operating hours. Manager on duty cannot consume alcohol either. Ms. James also applied for a manger's card today. All employees employed should have an ABC card and health certificate. Chairman Leon Guerrero emphasized that if violation occurs again, alcohol beverage license will not be renewed.
