**1.) Alcoholic Server/Training Program**

*Members of ABC Board were issued/provided copies on Bill No.9-33(Cor)*

Pacific War Museum submitted letter to the board to explain that patrons of PXC who are allowed to drink will wear wristbands as identifiers and will not be allowed to take alcohol outside the Calvo Fieldhouse during the event.

7.) *Shamrock*

Chairman Leon Guerrero visited Shamrock and found that there might be a ratio issue. He suggested that the bar and grill is operating as a bar but with a restaurant license to bypass ratio. He's asking the ABC branch to seek AG's opinion on restaurant opening along bar.

8.) *Chairman Leon Guerrero's term to serve on ABC Board*

Chairman Leon Guerrero has turned in renewal package and his term expires on June 30 and is only allowed 90 days to be acting board member. After 90 days his term expires. He has not heard from the Governor's office about his confirmation hearing and status of his renewal package.
