Subject: *Minutes of Alcoholic Beverage Control Board Meeting – September 9, 2015*

Meeting was called at 5:07pm by Chairman Leon Guerrero. In attendance were Vice Chairman Rey Llaneta, Secretary Tiffany Tam, and member John Ray Taitano. Member Bing Mejia was absent. ABC personnel present was Acting Supervisor Joe San Augustine.

Guests present were Mr. Marcus Cepeda from ServeSafe, Grace Donaldson; Philip Guerrero, Mary Okada Ed.D, Rowena Perez, Vicky Shrage and Eric Chong from Guam Community College.

I. Old Business: Minutes of Meeting – August 12, 2015 tabled  
August 26, 2015 approval  
Feb. 25, April 8, June 24, and July 29, 2015 pending approval

John Ray Taitano motioned to approve minutes of June 24 and August 26. Chairman Leon Guerrero seconds the motion. None opposed. Motion carries. Minutes of June 24 and August 26, 2015 are approved.

John Ray Taitano motioned to review new business due to lack of minutes provided. Tiffany Tam seconds. None opposed. Motion carries.

## II. New Business:

**D.) The Alcohol Server/Training Program** was moved to discuss first due to guests at meeting. The floor was given for questions and presentations.

### 1.) Serve Safe

Mr. Marcus Cepeda from Serve Safe attended meeting for a follow up of his presentation. Chairman Leon Guerrero's concern was cultural interface wasn't strong in training packet to provide a deeper understanding and preparation for servers to serve different ethnicity of customers. There are clubs on Guam cater to specific ethnicity, and they behave differently after alcohol consumption. The board cannot sanctify program to break laws. Joe San Augustine advised the board that formal comments still need to be submitted to the administrator; cannot be casually addressed or else more dialogs will follow. Ms. Grace Donaldson further added that CSR have access to provide translator. Chairman Leon Guerrero emphasized that the cultural interface of training needs to be strengthen in his training manual. With no further questions and comments, Mr. Cepeda and Ms. Donaldson exited meeting.

**2.) Guam Community College TAM program**

Philip Guerrero began the presentation by explaining of what TAM is. TAM stands for Techniques of Alcohol Management. TAM is a nationwide program, which has number two in market share and the number one program in Las Vegas, NV. This program began in Michigan. Mr. Guerrero also explained the importance of this program, what do employees gain from the training, benefits of undergoing the training. It is a 3-hour training. The training consists of lecture and role-play. Class size is approximately 20-30 students. There are currently eight (8) certified trainers, which two of them were present in meeting. Mr. Chong and Ms. Shrage have a combined experience of 40 years. There are also 14 full time instructors teaching Tourism and Hospitality at GCC. They have the capacity to train and certify more college adjunct professors as additional instructors. After preliminary review, the board asks GCC to send amendments to the following:

- a. Need copies of test scores and results of current trainers
- b. How many classes will be instructed
- c. State that they can provide flexible schedules and on-site training
- d. Trainer's manual

There were no further comments and questions, GCC guests exited meeting. The board now resumes to Item A on agenda.
