Alcohol Beverage Control Board Meeting was called to order at 4:03 PM by Chairwoman Ms. Fisher via zoom. Mr. Ilao was present. Mr. Pangelinan called in via Zoom. ABC Compliance Supervisor, Craig Camacho was present. Compliance Inspectors Lujan and San Agustin was present. John Ryan, Attorney Brad Huesman, and Rodney Webb were present via Zoom.
