Supervisor Camacho noted that with the increase of temporary applications, he asked the board to reconsider meeting twice a month. Board member Pangelinan stated the reason to changing to once a month was due to the back up at the compliance branch and budget concerns.

Camacho responded that a new public law passed requiring the agenda to be posted according to open government law. And vendors require a 2-day deadline to submit ad proof. Meaning the amount of time to publish the meeting would take 13 days before the meeting. If we were to have a 2<sup>nd</sup> meeting, the deadline to submit ad proof to vendors would be 2 days after the first meeting of the month. Compliance team was doing more quantity than quality.

Chairwoman Fisher asked how the change to two meetings will affect the work of the compliance team. Camacho responded saying that it would get rough on his staff. Pangelinan brought up the issue of quorum.


