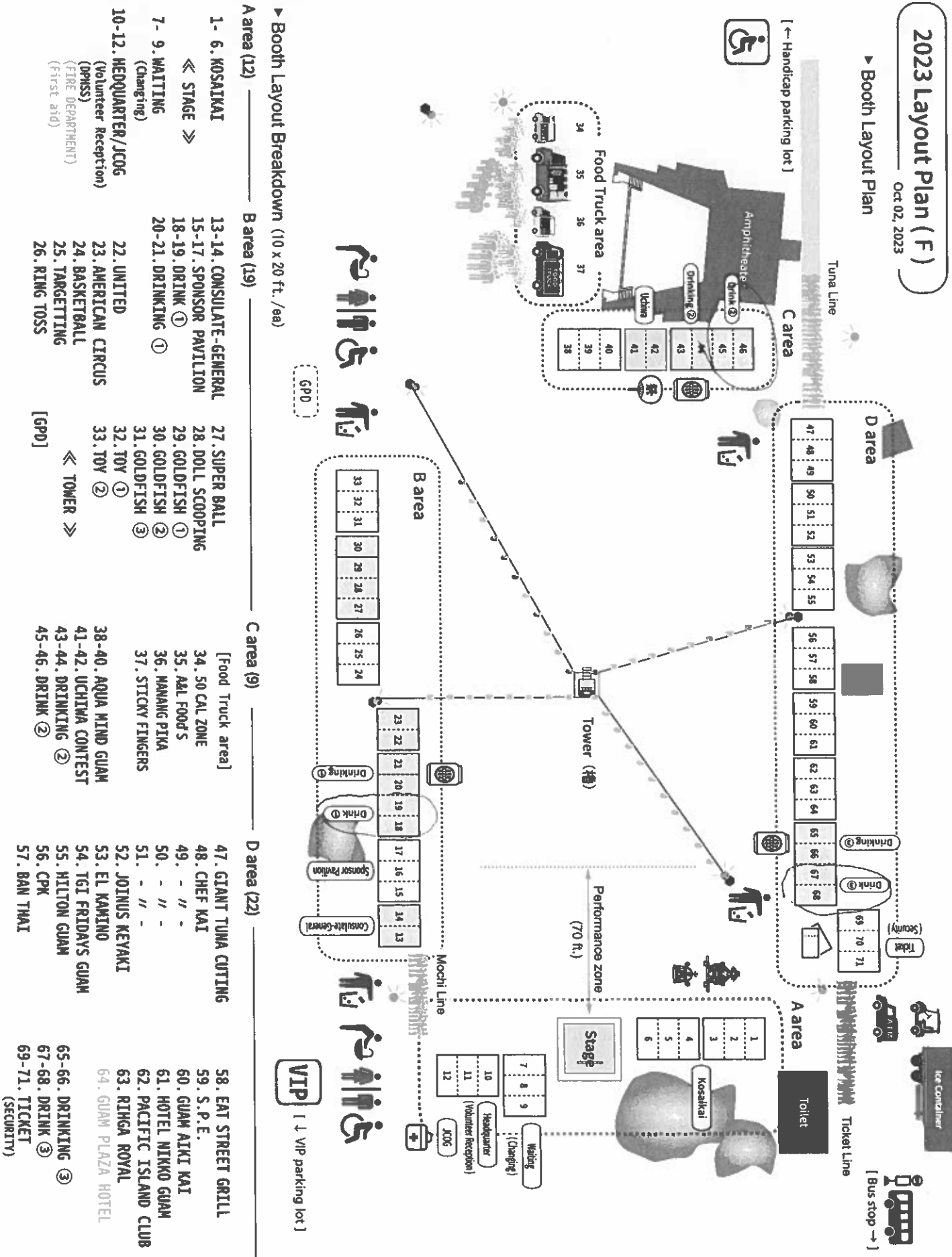
▶ Drink Booth Layout Plan
