- a. Mr. Camacho stated the suspension of Toy's Tavern's alcohol license ended on July 18<sup>th</sup>. The Compliance team returned the seized alcohol back to Mr. Potter, along with his alcohol license, and suspension signs were removed from the premises.

(B) Alcoholic Beverage Compliance Fees & Fines Fund

- Purchase of Government Officials
  - Mr. Camacho reported that the funds current balance is \$204,885.00. Most funds are received through the ABC cards and the fine and penalties that Compliance branch issues. Mr. Camacho is seeking Board approval for the purchase of 2 vehicles for alcohol enforcement. Mr. Camacho stated that the Compliance Branch is currently utilizing a 2009 Toyota Highlander and a 2006 Ford Escape.

Regarding equipment, Mr. Camacho is looking to establish uniforms for the inspectors, as well as use of force policies with 3 of his inspectors who are Post certified.
