Subject: Alcoholic Beverage Control Meeting Minutes – September 14, 2016

Meeting is called to order at 5:05 P.M. by Chairman Rey Llaneta, Vice-Chairman Bing Mejia and Acting Secretary Richard Hamlin are present. From the ABC Compliance Branch Mike Certeza, David Santos Vicente Bautista and Craig Camacho were present.

Old Business:

D) Other items for Discussion(s):

- 1). By unanimous approval of the Board, the **PHRS** package resubmission for a new non-profit organization to conduct the Alcohol Seller/Server Training Program under **Center for Micronesia Empowerment (CME)** name change was conditionally approved, so long as all outstanding requirements are met prior to actual license issuance.

2). ADDITIONAL CONSUMPTION AREA:

a) **Guang Li Sheng, Inc. dba: Drop Lounge. A Class 4 General On Sale License #13572.** Request your approval for additional consumption area of 14' x 40" adjacent to existing location of said establishment. Representative of Drop Lounge submitted two letters, (one dated August 23 and one submitted at present meeting) requesting extension of consumption area, proposed extended consumption area is area belonging to different, former license holder ("Kraken") and is not presently indicated by lease or business license as being under the control of Drop Lounge license holder. A sketch and photographs were submitted to indicate that the a wall has been broken to permit internal ingress and egress between the two different areas. No report of fire inspection was provided to indicate that newly constructed internal ingress/egress or formerly licensed bar area is in compliance with relevant fire and safety regulations. It was noted by ABC Compliance Branch and Drop Lounge representative that an ABC violation was noted during an inspection on July 30, 2016 at approximately 2:00AM. The basis for the violation was that the Drop Lounge license holder had erected a new (and apparently in possible violation of relevant fire code) internal doorway and was serving alcoholic beverages and operating a bar business in the former Kraken license holder area. At the time, the former Kraken license was expired, (the business apparently defunct or transferred to a new owner), and there was no valid license for the area in which Drop Lounge was operating, either through an extension of the Drop Lounge license or through a valid Kraken license. Drop Lounge representative acknowledged the mistake and violation in its operations. Noting that a written violation report has not been reviewed by the Board, the Board requested ABC Compliance Branch to file a written report relevant to the July 30, 2016 inspection violation finding. The board withheld action relative to Drop Lounge's request

until such time as an updated lease and business licenses are submitted to reflect Drop Lounge's lawful control of the extended area and until such time as the Board has reviewed the written violation report. The Board stated that so long as two managers were present during all operations of the two areas, and the extension (including construction) were approved and documented as in compliance with relevant fire and business licensing regulations, the Board would be amenable to the consolidation of the two areas to one license holder. Richard Hamlin abstained from the matter.

E) Meeting Adjourned:

The Board meeting was adjourned at 6:15 P.M.
