Alcohol Beverage Control Board Meeting was called to order at 5:07PMbyChairman Llaneta. Ms. Leon Guerrero, Ms. Fisher, and Ms. Okuhama were present. Mr. Kerber was in apology. Compliance Inspectors Craig Camacho, Vicente Bautista, and Gerard Aflaguefrom ABC Compliance Branch were present.
