Alcohol Beverage Control Board Meeting was called to order at 5:09PM by Chairman Llaneta. Ms. Leon Guerrero, Ms. Fisher, Ms. Okuhama and Mr. Kerber were present. Compliance Inspectors Craig Camacho, Vicente Bautista, and Gerard Aflague from ABC Compliance Branch were present. Mr Jay Merrill, Investor, Guam Brewery Tap House, was also present.

Old Business:

Meeting minutes for December 19, 2018 were approved by the Board.

New Business:

A) Memorandum dated January 9, 2019:

AG No. 18-0195

Mr. Camacho provided a summary of the case to the Board and explained that the case involved 2 separate issues for which the Board is required to provide written recommendations. The first issue is a civil matter whereby the Petitioner has requested the Attorney General of Guam (AG) to release perishable products that were seized by Guam Customs & Quarantine due to improper licensing. As marketability of the products is soon to expire, the AGs office is requesting for the Board's recommendation of the disposition of the products.

The Board determined that based on the facts stated in the Petition for Remission or Mitigation of 191 Kegs, there was no intent for the Petitioner to violate or circumvent the law. The Board voted to release the products to MidPac Distributors, Inc. (a properly licensed consignee) such that Petitioner could move forward with its business. Ms. Leon Guerrero moved to approve, motion seconded by Ms. Okuhama and approved without dissent. Chairman Llaneta confirmed he would prepare a response to the AGs office tomorrow.

The second issue is a violation for which a report is forthcoming.

Ms. Okuhama left the meeting.

B) Violation Report:

Case Number ABC-2018-12-001

The Board inquired about the ownership of HM Corporation and the impact of the violation on the vendors who distributed the products. Mr Camacho explained that according to records on file there are a total of 3 owners – 2 in Korea, 1 in Guam. Mr Camacho also clarified that the Compliance Branch is in the process of determining the chain of ownership as the Inspectors have identified a pattern in the manner by which HM Corporation changes ownership. Mr. Camacho advised the Board that it may recommend fines/penalties on the vendors as deemed necessary.

The Board voted to impose fines on HM Corporation and all 3 vendors who distributed alcoholic beverages to the unlicensed company. Ms. Leon Guerrero moved to approve, motion seconded by Mr. Kerber and approved without dissent. Chairman Llaneta confirmed he would prepare a letter to HM Corporation informing them of the fine tomorrow.
