Meeting was called to order by Chairperson Franklin Leon Guerrero on April 22, 2015 at 17:10. In attendance were Secretary Tiffany Tam, and Member John Taitano. An ABC personnel present was G. Mike Certeza and Acting Supervisor Joe San Augustin.

I. Old Business:

Approval of minutes was tabled. Minutes from February 25, 2015 and April 8, 2015 were still pending for approval.

II. New Business:

A. Alcoholic Beverage License Applications:

1. The Application for a Class 4 General On Sale alcoholic beverage license by the following business was given approval by unanimous vote of the Board provided all conditions are met before the actual license is issued. Chairman Leon Guerrero motioned to revise past board policy by recommend to remove thirty (30) days prior requirement for all temporary liquor license applications. This would allow more applicants to turn in at least two (2) days prior board meeting to be included in the agenda. Motion was second by Member Taitano. None opposed; motion carries.

Member Taitano raised a question whether it is legal for an establishment to turn customers who are under the legal drinking age if the establishment is holding a fundraiser. It is recommended to pull the original Class for liquor license for verification. ABC Branch inspector will investigate further.

D. Other items discussed

Acting Supervisor San Augustin will assist in drafting rules and regulations for board to review to move forward. Will contact Mary Rhodes as resource, and will also contact Senator Rodriguez for discussion including updates and timeline.

2. *Trade name Change*

The board unanimously approved the following trade name change:
