**D) Other items for Discussion(s):**

**1) Alcoholic Server/Training Program**

Response letters have been sent to the respective organizations who had submitted their proposals. Mr. San Agustin of ABC suggested the following policies to the board for approval and to be added to the Alcoholic Server/Training Program.

- a.) Instructors be required to provide police clearance. Similar process as applying for a manager's card.
- b.) Manager and server requirements to be retained and ABC compliance branch be informed of all employment.
- c.) Manager and server be allowed to be issued a temporary card of minimum 90 days to 180 days in the event that course is not available.
- d.) Alcohol/Server Training Program licensee shall be required to get a AG clearance and the clearance as applicable. Also all business licensees requirement as applicable.

- e.) Course dates must be provided to ABC compliance branch to assist in temporary license.
- f.) Temporary license must include serving listing (applies to non-profit as well)
