Per DS-11 Applications, Applicants/Parents/Legal Guardians MUST PROVIDE & Submit certified U.S. citizenship evidence and a photocopy of the front (and back, if there is printed information) of the U.S. citizenship evidence you're providing to us. Photocopies must be:

- Legible
- On white 8.5"x11" standard paper
- Black and white
- Single sided

Per DS-11 Application, Must submit a photocopy of the front and back of each ID that you PRESENT when you apply. Photocopies must be:

- Legible
- On white 8.5"x11" standard paper
- Photocopy cannot be double-sided.
- Do not decrease the image size (although you may enlarge it.)
